All students who are under 18 years of age until 8th September 2024 must live in our boarding accommodation, or with a parent, appointed guardian or close relative. A close relative is defined under the Children Act 1989 as a grandparent, brother, sister, uncle or aunt, whether of full blood or half blood or by marriage.

Boarding fees are inclusive of breakfast, lunch and dinner Monday-Friday, and brunch/dinner at weekends (snacks are available on weekends in common kitchens for early risers). Weekly bedlinen and towels, high speed internet, 24/7 live-in House Parents, electronic security door entry system, onsite night security, laundry facilities, and weekly activities programme. Some activities are available at additional cost.

All rooms contain a comfortable small double bed, desk and chair, and wardrobe with drawers and storage space. Standard single rooms are in 2/3 bedroom clusters with 1/2 shared toilet/shower rooms. Ensuite single and studio rooms contain a luxury shower room with toilet and washbasin.

Booking your Boarding Accommodation

Minimum booking for boarding accommodation is one academic year unless otherwise stated. Accommodation is available for students for the duration of their studies at the College. Should a student finish earlier for any reason, they will need to leave the Boarding House.

Arrival dates commence 8th September 2024. Check-ins are between 9.00am and 5.00pm, unless otherwise arranged via the accommodation team.

Accommodation is subject to availability and early booking is advisable. Bookings are confirmed only after course deposit payment and registration fee are received by the College.
